Reports

- Chairperson. Personal comments regarding her journey in service. '7 Deadly Needs':

 Luanne K directly). Nar-Anon is not only a 'me' program but is a 'we' program. She has
 experienced growth through her two years of service as Chair while the region has
 grown as well and extends her thanks for the opportunity.
- Vice Chair. Nar-Anon has been a life saver for her personally. She has experienced growth and thanks those that have been.
- Secretary. Provided background on entry into service. Reviewed role responsibilities.
 Encouraged anyone interested in serving on the RSC to approach members individually with questions. Challenged group to serve.
 - September Minutes. Electronic copies sent out prior to the meeting. Hard copy available at the meeting. Minutes were approved unanimously without changes, corrections or amendments.

- Treasurer. Provided insight as to why she chose to serve and continues to do so. 'I serve because I want to give away what has been so freely given to me. I serve because I want to be a guardian of the Nar-Anon program.'
 - o Treasurer's Reports. Ending balance (as of Oct 15, 2013): \$4,508.61.
 - o Proposed Budget 2014.
 - RSC proposes an increase of approximately 10%
 - It is proposed a line item be added (new for 2014): WSO Donation
 - Discussion
 - Last year GSRs voted to define prudent reserve as 10% of the total budget.
 - MOTION: Midwest Region should send \$350 to WSO. Seconded. Floor opened for discussion. It was questioned as to the advisability of sending money to WSO at this time as there continue to be outstanding expenses. It was shared that some groups are donating directly to the WSO. Unfortunately we have no idea how much. It was shared that we currently have outstanding expenses. We need to have a full budget plus 10%; any funds that exceed that amount should be sent to the WSO. Midwest Region did not meet the 2013 Budget (collections were less than the regional budget). AMENDED MOTION: At the end of the year, with full year expenses and revenues accounted for (to include all Assembly related expenses), a balance that exceeds our prudent reserves will be sent to WSO (up to a limit of \$350). The AMENDED MOTION PASSED UNANIMOUSLY.
 - Treasurer's Report. MOTION TO APPROVE. Unanimously APPROVED as presented.
 - 2013-2014 Proposed Budget. MOTION TO APPROVE budget of \$5,695.00. Unanimously APPROVED (8 yes votes).

 - Shared regarding her personal journey to service. 'If I had waited to begin service on my terms, I wouldn't be serving now.' 'Service is helping me find my voice.'
