**Teleconference Minutes:** The following Motion passed unanimously: To place an Addendum on October 2013 Assembly Minutes to reflect that Ruth M was voted as Alternate Delegate for the Midwest Region and that Delegate Jan F was given a vote of confidence to carry the voice and vote of the Midwest Region to the 2014 Nar-Anon World Service Conference. As required, the Amended Assembly Minutes will be sent to WSC Committee in preparation for 2014 WSC.

**Treasurer Report:** Our outgoing Treasurer (Donna) has forwarded a final financial report for the region. Donna has closed the region's bank account, and forwarded a closing check to Tonia M Chair. Chair has opened a not for profit account at Regent's Bank, which has offices in all four states. A current financial report will be prepared and emailed to GSRs. Motion to approve Tonia M Chair and Cyndee D Vice Chair to be cosigners on the new account (until the positions of Secretary & Treasurer are filled) passed unanimously.

**Outreach Challenge**: The March Monthly Outreach Challenge is directed to school counselors. Due to extended school days (snow), this is a good time to leave information, meeting lists and brochures with school counselors. School counselors are often the first outside persons aware of a drug problem in the home. In speaking

with the counselors, please suggest Nar-Anon meetings as a valuable resource for parents and family members.

**Delegate Report**: Jan F and Ruth M held the first of three CAR/CAT conference calls, which covered the first 22 Motions. Tomorrow night at 7 pm, they will begin with Motion 23. - **2.** A continuing call is made for volunteers to fill open positions within the region. These include Treasurer, Secretary and Convention Committee (one member from each state). - **3.** After discussion, a call for voting on amending the new group literature package was made. Motion: **We move** that the Midwest Region add the Outreach Folder, a cost of \$3.50, to the list of items sent to the new groups. We also would like the new groups that have purchased the New Meeting Packet to have the option to receive an Outreach Packet instead. In addition, the list of "New Family Group Literature Packet" materials should be included in the Welcome Letter to the new NFG's. Motion passed unanimously.

- **4.** Joseph L GSR Maryland Heights, MO presented an oral motion to instruct the Delegate to withdraw the region's WSC Motion #16 from the CAR. Although there was discussion held, no 2<sup>nd</sup> was received, and the Motion dies.
- **5.** Tonia M Chair informed GSRs that due to confusion and not wanting teleconference tapes deleted, she changed the password for access to regional teleconference tapes. After discussion, the GSRs voted to have access to the password held by Tonia M Chair and Cyndee D Vice Chair until further motion. Passed unanimously without formal motion.
