That is what makes us strong, we each have an important role.

 - Shannon was grateful for the topic and Cyndee was glad to hear more about how Tradition 7 is about much more than just money.

- Group Talk
 - 1) What does your group pay for your meeting space and how does your group address reporting of finances to group members?
 - Lynn (Rockford IL) In the past we were paying 90% of our donations, we moved and now and they asked us what we would pay and we agreed on 20% of our basket. It now allows us to send money to the region. The finances are reported monthly at the business/group conscience meetings. A report is also sent out via email to group members that may not have been able to attend.
 - Bill (Homewood IL) His group pays \$20/month set by the facility. Finances are reported each week during announcements.
 - Ilene (Schaumberg IL) People are active at the church they meet in so the space is free. Now and then they give an at-will donation for the space. They do not do treasurer reports.

- Kelly (Glen Carbon) has been attending for a few years and is not sure what they pay for the space, she now wants to find out.
- Patty (Indianapolis IN) They are located in a hospital and use space at no charge. Her group's treasurer reports their finances each week during announcements.
- Karen (Van Buren AR) Their group pays \$15/month to the NA group that rents out the building.
- Dian (representing Des Peres) Never found out and there is rarely a report of finances since there is no Treasurer. Will find out and report back.
- Dale (Chesterfield MO) reports monthly during announcements. At another meeting he attends there is no
- Linda (Springfield IL) They give donations to the church (no set amount) and report the finances each week.
- Theresa (Alt Delegate, attends Shawnee) shares that her group reports finances every four months and could answer questions upon request.
