- **Long Distance Sponsorship**

Lengthy discussion re sponsorship. RSC is uncomfortable with “matchmaking” an individual with a sponsor. Agreed that if members are willing to be long distance sponsors, their info can be posted on website as a resource pool. We are a young region, only 6 years old. It is necessary to “build our foundation” through meetings, steps, traditions, sponsors, service. All sponsorship should lead back to the program. The answers we seek are in program, we are learning new ways to live. Having a sponsor gives us a place to practice “living” the program. We can trust that we will find what we need by asking for guidance from our HP, and also from any number of people who are put on our path. Be open.

Theresa will develop a sponsorship page, which can be fleshed out by others. RSC Committee members as well as other regional members are encouraged to share their experiences of being a sponsor or a sponsee. This will be beneficial to others who are considering asking for a sponsor or trying to figure out what sponsorship really is all about.
