## Joseph stated the following:

Guided by the Group Conscience of New Choices Nar-Anon Family Group, I move that Nar-Anon Midwest Region purchase "Ask Me about Nar-anon" buttons from New Choices and that the Midwest Region handle all procedures for the subsequent sale of these buttons as a fund raising project for Delegate Expense.

Discussion followed. Paula wanted clarification that New Choices Group will purchase...and region will purchase from them group. Sharon asked about current inventory. Joseph stated 45 that aren't perfect. Inventory is 0. Tawnee inquired about regional cost. Joseph will send info to Sharon who will distribute information to all GSR's. Donna asked if there a profit made by New Choices because of difference in order cost...and regions purchase price. Handling will be done by Region. Robin...asking who will be the designee for the region. Linda from Tues together...for candy, asked about Wso taking over this. Joseph stated an offer was made to WSO and WSO did not approve because of some concerns. Tawnee..wso has NOT disapproved taking this over. Tawnee stated she thought these were the same prices quoted to WSO. Tawnee concerned price for sale. What is the market going to be? Sean asked if it is ok to use the logo. NA pays a licence fee to NAwso. There is NO current Naranon Logo on the buttons.

Sean asked if the buttons were CAL approved?

Pricing that was discussed during the meeting was 100-249 buttons \$1.50 each plus shipping and handling. 250-499 buttons \$1.20 each plus shipping and handling.

Sharon suggested this get tabled pending more detailed description of the various transactions in writing from Joseph..
