Motion 22: In the GLS on p1-3, Membership in Nar-Anon and Narateen, this motion requests removing the P "Anyone who feels their life has been affected by close contact with an addict is eligible for membership in Nar-Anon. Using their knowledge of the 12 Steps and 12 Traditions, Narateen facilitators guide groups and keep meetings focused on topic. Narateen meetings are closed, except by Group Conscience." Replacing with this P "Anyone who feels their life has been affected by close contact with an addict is eligible for membership in Nar-Anon. Narateen is part of the Nar-Anon program for teens (ages 13 and up to the age a person is considered an adult in the country in which they reside) affected by someone else's addiction."

From: Southern Iran
Rationale-To clearly define Narateen membership and age.
Point of Interest : This language, regarding age, already exists in the GLS p7-2 Membership in Narateen. Removing the original P removes the important language of facilitator responsibilities and the clarification that Narateen meetings are closed meetings except by Group Conscience.
Discussion Notes:

Motion 23: In the GLS p3-4 Meeting Ideas. There are 8 meeting ideas listed. They are: Topic, Personal Stories, Beginner, Step, 12 Trads, 12 Concepts, Slogans and Visiting Speakers. This motion requests the addition of 2 new subsections and 1 change to an existing meeting.

Suggested Recovery Meeting Durations: Nar-Anon meeting 60-90mins, Beginner meeting 30-45 mins, either right before or right after Nar-Anon meeting. Business Meeting: Determine duration by Group Conscience either before or after the regular Nar-Anon meeting.

Panel Meeting: Ask 3-4 members to share their experience on questions submitted by the group members.
Motion also requests adding the word recovery in front of the word meeting to read, recovery meeting, in the Personal Stories meeting description.
Intention: This will help new meetings because there are no suggested time durations for meetings.
Q. Do we need to have a set duration for a meeting? Do we need to list all the different ways we can share about recovery? Do all groups hold their business meetings or Group Conscience meetings before or after a regular meeting?

Motion 24: In the GLS p4-1 Group Structure, Duties of Group Officers, Chair/Leader delete the last 2 bullets: "Helps establish committees, if they are necessary", and "Can act as Chair of the steering committee if there is one."

This is one of a handful of motions this year concerning keeping the focus of NFGs on their primary purpose of helping families of addicts and the local NFGs should not be burdened with committee work. Committee work appears to be getting handed up to the areas and regions.

Rationale: The group has but one purpose... Committee work violates Trad 5 and Concept 1. "To fulfill our primary purpose, we join together to create a service structure that develops and maintains services on behalf of Nar-Anon." Establishing committees within the group may cause an overload of service duties.

Motion 25: In the GLS p4-2 Group Service Representatives (GSRs) remove "GSRs are elected by their groups to a three year term." Replace with "GSRs are elected by their groups for a minimum of one year, up to a maximum of three years."
